1. This permit is issued and accepted subject to conditions contained herein as well as all rules, resolutions, regulations and ordinances of Big Prairie Township and the Big Prairie Township Park Commission.
2. Your permit may be revoked without refund and without prior notice, and eviction may occur if you, your family, or guests violate any park regulations or any of the conditions contained herein. Furthermore, any error in the information provided by the applicant as required above will be grounds for immediate revocation of this permit and eviction from the campgrounds.
3. The applicant acknowledges and agrees that this permit can be revoked, and the applicant may be evicted immediately and without notice upon non-payment of any required monetary obligation or upon violation of any township or park commission ordinance, state or county law, or campground rules or regulations.
4. The applicant/s agrees to keep a current credit card on file with the park and authorizes park personnel to bill the card for any unpaid monetary obligations.
5. The parties hereto agree that Big Prairie Township and the Big Prairie Township Park Commission (as well as any such entities agents, officers, and employees) and the campgrounds parks will not be liable for any loss, damage or injury to any applicant, person, or any personal property within the campgrounds due to fire, theft, act of God or any other cause whatsoever. Each applicant and the applicant's guest and family shall reimburse and hold Big Prairie Township and the Big Prairie Township Park Commission (and such entities, agents, and employees) harmless for and from any and all damages, costs, injury and or liability to or caused by the applicant or the applicant's family or guests. Furthermore, the applicant agrees to reimburse and hold the Park Commission and the Big Prairie Township (and their employees and agents) harmless from any claims, actions, suits, for any personal injury or loss or damage to any personal property sustained by the applicant (or the applicant's family or guests) for and from any claim, action, suit for personal injury and all other liabilities resulting from the use of the parks, campgrounds, or facilities.
6. **No refunds will be issued on or after May 1st for seasonal campsites or docks.**
7. This document shall be deemed to be a camping and/or dock permit once signed by a representative of the campgrounds. **Any infraction of this permit or the rules resolutions, regulations or ordinances of Big Prairie Township or the Park Commission or any law shall be reason for immediate cancellation of this permit. Eviction from the campgrounds and/or removal of the applicant's property at the applicant's expense.**

I hereby acknowledge receiving a copy of the rules and regulations of the campground and dock use and agree that I/we (as well as our guests and family) will fully abide by the same.
